Release, Assumption of Risk, Waiver of Liability, and Indemnity Agreement



This document waives important legal rights. Read it carefully before signing.

I AGREE for myself, and/or my child, in consideration for participation in this equestrian activity to the following:

I AGREE that I choose to participate voluntarily in an equestrian activity. I am fully aware and acknowledge that horse activities involve inherent dangerous risks including, but not limited to, broken bones, head injuries, trauma, pain, suffering or death ("Harm"). I fully understand that this release covers, but is not limited to, inherent risks of an equine activity— a danger or condition that is an integral part of an equine activity— including but not limited to, any of the following:

- The propensity of an equine to behave in ways that may result in injury, death, or loss to persons on or around the equine;
- The unpredictability of an equine's reaction to sounds, sudden movement, unfamiliar objects, persons, or other animals;
- Hazards, including, but not limited to, surface or subsurface conditions, obstacles, jumps or other hazards;
- A collision with another equine, another animal, a person, or an object;
- The potential of an equine activity participant to act in a negligent manner that may contribute to injury, death, or loss to the person of the participant or to other persons, including but not limited to, failing to maintain control over an equine or failing to act within the ability of the participant.

I AGREE to release River Run Equine LLC personnel, volunteers, trainers, affiliated organizations and Becky Mathews from all claims of whatsoever kind or nature in law, including claim or remedy of any kind whatsoever arising out of or in any way connected with any Harm to me or my horse and for any Harm caused by me or my horse to others.

I AGREE to expressly assume all risks of Harm to me or my horse, including Harm resulting from the negligence of River Run Equine LLC or a River Run Equine LLC activity, and specifically agree to the applicable state statute/laws regarding equine/farm animal activity liability and signed posting (if any), in any state in which I or my child participates in the activity.

I AGREE to indemnify (that is, to pay any losses, damages, or costs incurred by) River Run Equine LLC or a River Run Equine LLC activity and to hold them harmless with respect to claims for Harm to me or my horse, and for claims made by others for any Harm caused by me or my horse in the River Run Equine LLC activity.

I AGREE to release, discharge, defend, indemnify, and hold harmless Becky Mathews and River Run Equine LLC from any claim, demand, liability, action, suit, loss, cost, or expense including reasonable attorney's fees, resulting from damage to property or injury to or death of any person arising out of or in any way connected to riding, jumping or training of horses either on or off the farm premises, or the participation in any clinic, show or event whether such loss, damage, injury or death by caused in whole or in part by the negligences of River Run Equine LLC, Becky Mathews, or any other person, whether on or off the farm premises.

In the event this form is signed by the parent/guardian of a child, then all representations and acknowledgements herein are expressly made by, for, and on behalf of the parent/guardian and the child. By signing below, I AGREE to be bound by all applicable River Run Equine LLC rules. I acknowledge that I enter into this release after having read the same, and place my signature hereto of my own free voluntary act and deed. By signing below, I represent to River Run Equine LLC that I fully understand the contents, that I do not need any further explanation, and I waive any further explanation.
